WARDWELL AVENUE SEWER PROJECT UPDATE

The long awaited Westerleigh sewer project that will improve storm and sanitary sewers throughout a large portion of Westerleigh has finally been assigned to a contractor. The actual construction will begin after the close of the school year. Among the affected streets are Wardwell, Fisk, Leonard, Waters and Deems Avenues and Markham and Dakota Places.

EE Cruz is the firm that



has been awarded the contract for the project and will work according to the specifications outlined by the Department of Design and Construction (DDC). Prior to the start of work, there will be a community meeting to which all residents affected by the

construction will be invited. The scope of the work will be explained and the Community Construction Liaison will be introduced. The Liaison will be an individual who will act as the go-between for homeowners to the contractor. Every effort will be made to address issues such as parking and access before the actual excavation begins.

As the Society receives more information we will inform residents of the latest updates. ♪

WESTERLEIGH IMPROVEMENT SOCIETY FINANCIAL CONSIDERATIONS



As many of you are aware, the Society has carefully handled our financial matters over the years

with extreme care. Most of the work running our civic group is done by volunteers and we rarely outsource any work. Our treasurer, Ed Malone, has nurtured our financial assets so that we can provide the best service possible for the Westerleigh community.

Over the recent past, many pressures have caused the



Board of Directors to reexamine our income flow.

Postal costs, permits, supplies and, most recently, insurance premiums, have increased the demands on our treasury. We have found our annual expenses outstripping our income from dues. Because we prudently set aside reserves for such a possibility

our operations are still continuing normally. However, we cannot keep dipping into our reserves on a sustained basis.

At our Annual Meeting in May, the Board of Directors will propose a dues increase to \$20 per year for regular membership and \$30 per year for associate membership beginning January 2018. This will be our first dues increase proposal since 2004.

The Directors wanted our members to know that the request is made out of necessity and for the long term benefit to the community. ☺
